PATIENT EDUCATION: IDF PROVIDED EDUCATIONAL PROGRAMS ACROSS THE COUNTRY FOR PATIENTS AND FAMILIES LIVING WITH PRIMARY IMMUNODEFICIENCIES (PI). IN 2016, APPROXIMATELY 15,429 ATTENDED MORE THAN 233 PROGRAMS IN 128 CITIES IN 34 STATES AND TWO COUNTRIES. THESE INCLUDED LOCAL PATIENT MEETINGS, GET CONNECTED MEETINGS, TEEN ESCAPE WEEKENDS AND MEDICAL EXHIBITS. IDF COORDINATES AN OUTREACH PROGRAM WITH PLASMA COLLECTION CENTERS THROUGHOUT THE COUNTRY. APPROXIMATELY 2,827 PEOPLE WERE REACHED IN 86 VISITS TO PLASMA CENTERS THIS YEAR. OVER 290,000 IDF EDUCATIONAL MATERIALS WERE DISTRIBUTED.
